

Call for Applications and Instructions

100% Fund Grant Competition Infant Leukemia

MANDATE

Nearly one in five children diagnosed with cancer will not survive. For children with rare and hard to treat cancers, the odds can be far worse. The **100% Fund** has been created to challenge these odds. Phoebe Rose Rocks Foundation, Fight Like Mason Foundation, Mélia's Memory, Team Finn, Eli's Childhood Cancer Foundation, AnnFrances Tropea Foundation, Kindred Foundation and Childhood Cancer Canada have partnered to fund research for children and teens who do not, yet, have their cure.

The 100% Fund targets pediatric and adolescent cancers that are hard to treat—cancers that have not responded to available therapies. The goal is to fund research with the potential to deliver improved treatment and increased survival rates.

Phoebe was 9 weeks old when she was diagnosed with mixed lineage (MLL+) infantile leukemia. We were told that she had a 15% chance of surviving her disease and harsh treatment. Imagine knowing that your baby's chances of dying far far outweigh those that she will survive. It was, and will always be, completely devastating. Founded in 2016, The Phoebe Rose Rocks Foundation is inspired by the life and love of Phoebe Rose Doull-Hoffman and her quest to make it "okay" for kids with cancer. Our mission is to support and fund childhood cancer research, specifically research of cancers with low survival rates, and to provide support for Canadian families who need to travel far from home for childhood cancer treatment. We aim to drive research towards cancers that are difficult to treat and cure with the hope of finding a cure for every child. We saw first-hand the importance of and need for more childhood cancer research. It was research that gave us hope and allowed us precious years with Phoebe. The Phoebe Rose Rocks Foundation exists to continue this legacy of hope.

THE 100% FUND GRANT COMPETITION Infant Leukemia

We will accept **one application** addressing **Infant Leukemia** in consideration of the Round 4a 2023 grant competition.

Projects can range from discovery to clinical trials, but must be aimed at improving treatment outcomes, treatment options and/or quality of life.

The maximum amount awarded will be \$50,000 per year for 2 years (\$100,000 total maximum value).

This call for Infant Leukemia grant applications is part of the larger 100% Fund Grant Competition that is also funding research in rhabdomyosarcoma and osteosarcoma (Round 4).

Research Competition Process

- The 100% Fund grant competition in Infant Leukemia (Round 4a) will be a twostage process comprised first of a registration email indicating your intent to apply, followed by a full grant submission.
- Full grant applications, including a 4-page research proposal, will be reviewed and ranked by the C17 Research Network Committee.
- Consult the Award and Application Guide, available on the C17 website; not all instruction is available on the application forms.

- Register by email to <u>evani.goll@c17.ca</u> by <u>January 3, 2024</u>. Registration requires the name and email address of the Principal Investigator, and a draft project title. The registration information will not be reviewed.
- Grants submissions are due January 24, 2024 by 4:00 pm MT.
- Please submit one (1) electronic copy of the application via email. Application, proposal, CVs, appendixes and any additional supporting documents must be assembled into a SINGLE PDF file. Applications spread over multiple files will not be accepted.
- In addition to the PDF of the application, please send a word document containing the i) project title, ii) name and contact information of the ONE Principal Investigator, iii) names and contact information any co-Investigators, iv) lay summary (max. 150-200 words) and v) scientific abstract (max. 500 words). This document is for administrative purposes, and there are no formatting requirements. Do not submit a hardcopy. Keep the original signature pages on file.
